OLD BUSINESS

Weed Control Update

Steve Zulinski reported the lake was treated for milfoil and curly leaf pondweed. Algae is being controlled. A peroxide treatment was tried for the swimmers' itch but without good results. The best way to get rid of the snails that cause swimmers' itch is to rake them out of the water. Lily pads are becoming a nuisance in some areas. They are usually treated in the fall but are restricted to 160 square foot area and a 20 foot path from the dock to open water and only in developed areas. Steve will treat them this fall. Sediment is building up in some locations in the lake. Dredging is expensive and requires EGLE permits with many restrictions. Aerators work good to move dead leaves and sediment. Joan has spotted large growths of purple loosestrife. Steve explained the best methods to get rid of the loosestrife. Steve W asked if the materials used on roads would harm the lake. Unless it is used in high doses, most of it will dissolve. A depth study planned for spring was delayed because of the covid pandemic. Steve will do the study this fall. Overall the lake is in good condition.
