Rainbow Lake received a full treatment with a focus on milfoil on 5/18/21, with the next treatment scheduled for 6/23/21. Mark advised of a new product called Procelacore. This will last longer and is much more effective but will cost quite a bit more than the current plan. Mark will provide pricing options and payment plans at the next meeting.


NEW BUSINESS

There being no further business to come before the Lake Board, a motion was made by Todd and seconded by Bill to adjourn at 3:53 p.m. Motion carried.


