

**TAMARACK LAKE  
LAKE IMPROVEMENT BOARD  
HEARING OF PRACTICABILITY & REVIEW OF APPORTIONMENTS  
August 30, 2022**

A special meeting of the Tamarack Lake, Lake Improvement Board was held in the Lakeview Fire Barn, 117 Park Dr., Lakeview, Michigan on the 30<sup>th</sup> day of August 2022 at 6:00 p.m.

The hearing of practicability was called to order by Jourdan at 6:02 p.m.

Chairman Lindsey introduces the lake board members, Steve from Michigan Lakefront Solutions and Jacob & Zach from Keiser & Associates.

Board Vacancy

The vacancy on the board was filled by Colton Leppink, who was recommended and appointed as the Cato Township Representative by the Cato Township Board at their November 1, 2021 meeting.

A motion was made by Todd and seconded by Colton to accept the minutes of the July 18, 2022; meeting as presented. Motion carried.

Todd explained the procedures of the Hearing of Practicability and the Review of Apportionments and the necessity of both hearings.

Presentation

Steve introduced himself and explained the issues that he commonly sees on the lake. He explained what the weed control program is and how they operate under the regulations of EGLE. The major issues on the lake are Eurasian Milfoil and Curly Leaf Pond Weed. He explained the treatments that have been completed so far this season and provided an update on the

volume of weeds. Steve also spoke of the muck treatments that are being completed on the lake. The muck treatments help to get rid of the sediment on the bottom of the lake by clearing away the exotic species and allow the native plants to grow. Jacob from Keiser provided an update on the lake scans that were completed this season and advised the Elodia has improved greatly this year. Zach from Keiser provided detailed survey notes. Milfoil is starting to bloom later in the season and will likely need another treatment in the late fall. Zach stated that it may be beneficial to complete a study to find out where the nutrients are coming from and help to cut growth down in the future. Jourdan asked if there were any plants that they need to keep an eye out for in the coming years. Zach said that they have found Starry Stonewort in the lake near the boat launch. This plant requires aggressive treatments.

The chairman opened the meeting up to the public for questions and comments.

Melinda Marsh asked why lily pads took off so much this year. Steve stated that low water levels can cause the increase in growth. He explained that there are restrictions on lily pad treatments, but no limitations on harvesting.

Andy Zysk asked if lily pads can be pulled from the lake. Steve said yes, there are no limitations on manually harvesting lily pads.

Gary ~~Dolbe~~ Cass asked if the island being stripped has had an effect of the growth and nutrients in the lake. Jacob said that it was more likely coming from the runoff from the city and farm fields.

Andy Zysk added that he likes the idea of doing a study to find where the nutrients are entering the lake. Jacob and Zach agreed.

Lane Leppink asked if there are able to treat the purple loosestrife. Steve said that they can treat it and explained the regulations. He will need written permission from the homeowners to treat any purple loosestrife that is on land.

Andy Zysk asked if the purple loosestrife could be harvested from the lake. Steve said it could, but you have to be extremely careful because it will easily spread. Jacob added that there are also beetles that will eat the plant and advised that the beetles can be purchased.

Kristin Soloway asked if weevils can help. Zach said that weevils can be helpful, but they are very expensive and require a very large milfoil bloom to be considered necessary.

Todd asked if Keiser believes that the chemical program they are using is the best course of treatment for the lake as it is. Jacob said that he believes the chemicals are the best treatment for the current conditions.

John Soloway asked if there was anyway to treat in the winter to proactively cut down growth in the spring. Steve added there are currently no treatments in Michigan for winter application.

John asked about blue green algae. Steve that it can be toxic to humans and animals and should be reported as soon as it is found.

Melinda Marsh asked if the chemicals are safe. Steve added that the applicators would receive the most harm from the chemical treatments. Once they are added into the lake, they are diluted enough to not be harmful.

Jourdan asked if it was possible to harvest the lily pads for navigation. Steve said that they can, there are no regulations on mechanical harvesting. Todd added that there are several lakes in the area that do mechanical harvesting. Steve advised of the ups and downs of harvesting.

Todd read public comments that were received prior to the meeting.

Verna Carr – Supports the lake board and weed treatment program and is happy to help improve lake quality in any way possible.

Patty German – Asked why she is being assessed so much on a specific parcel. Todd advised that it was a split parcel that was not changed to vacant with the equalization department. The resident will have to sign an affidavit with equalization regarding the property class.

Janice Male – Stated that it is not a private lake and lakefront residents should not be the only ones charged for the weed control program. Todd advised that the entire Village of Lakeview is assessed and not just the lake residents.

Rosemary Imhoff – See attached. Todd advised that most issues brought up in the letter do not fall under the purview of the Lake Improvement Board. The lily pads can be treated for navigation, but since there is no dock on her property, they cannot treat the lily pads in front of her lot and they will have to be harvested.

There being no further questions or comments from the public, the Hearing of Practicability was closed by a motion from Todd and seconded by Colton. Motion Carried.

The Resolution to Proceed with Improvements was offered for approval to the Lake Board.



The hearing for the review of apportionments was called to order by Chairman Lindsey at 6:43 p.m.

#### Presentation of Special Assessment Roll

Todd presented the tax roll and explained the benefit factor used to determine the amount to assess each parcel.

Chairman Lindsey opened the hearing up for questions and comments from the public.

John Soloway asked if the lake association is able to apply for grants. Todd added that we are not a lake association, but a lake improvement board. He also added that there really aren't funds available to regular treatments and grants are generally reserved for new and emergent issues. Steve added that there used to be a grant to help with permit costs, but currently there is not.

John asked about mitigation grants to stop farm runoff into the lake. Jacob stated that he can look into it but grants are generally for new issues and education for the residents. Todd added that there isn't significant farm land butting up to the lake so farm runoff is minimal. Jourdan added that he will check out pricing for nutrient testing.


Melinda Marsh asked how many springs lead into the lake. Steve and Todd advised that they do not know. Steve added that he will be completing a survey of the bottom of the lake and that will show where the streams are.

Caroline Eastman asked about dredging the lake. Jourdan said that they may be allowed to dredge due to the large amount of sediment that has been dumped into the lake over the years. Todd added that the costs to dredge the lake would be astronomical.

There being no further questions or comments from the public on the Review of Apportionments, the hearing was closed by Todd and seconded by Colton. Motion carried.

The Resolution Confirming the Special Assessment Roll was offered for approval by the Lake Board.

There being no further business to come before the Lake Board, a motion was made by Todd and seconded by Colton to adjourn the meeting at 7:00 p.m.



The consultant would be responsible for conducting surveys of the lake to determine the scope of work to be performed by the plant control contractor and performing follow-up inspections to ensure work is performed in a satisfactory manner.

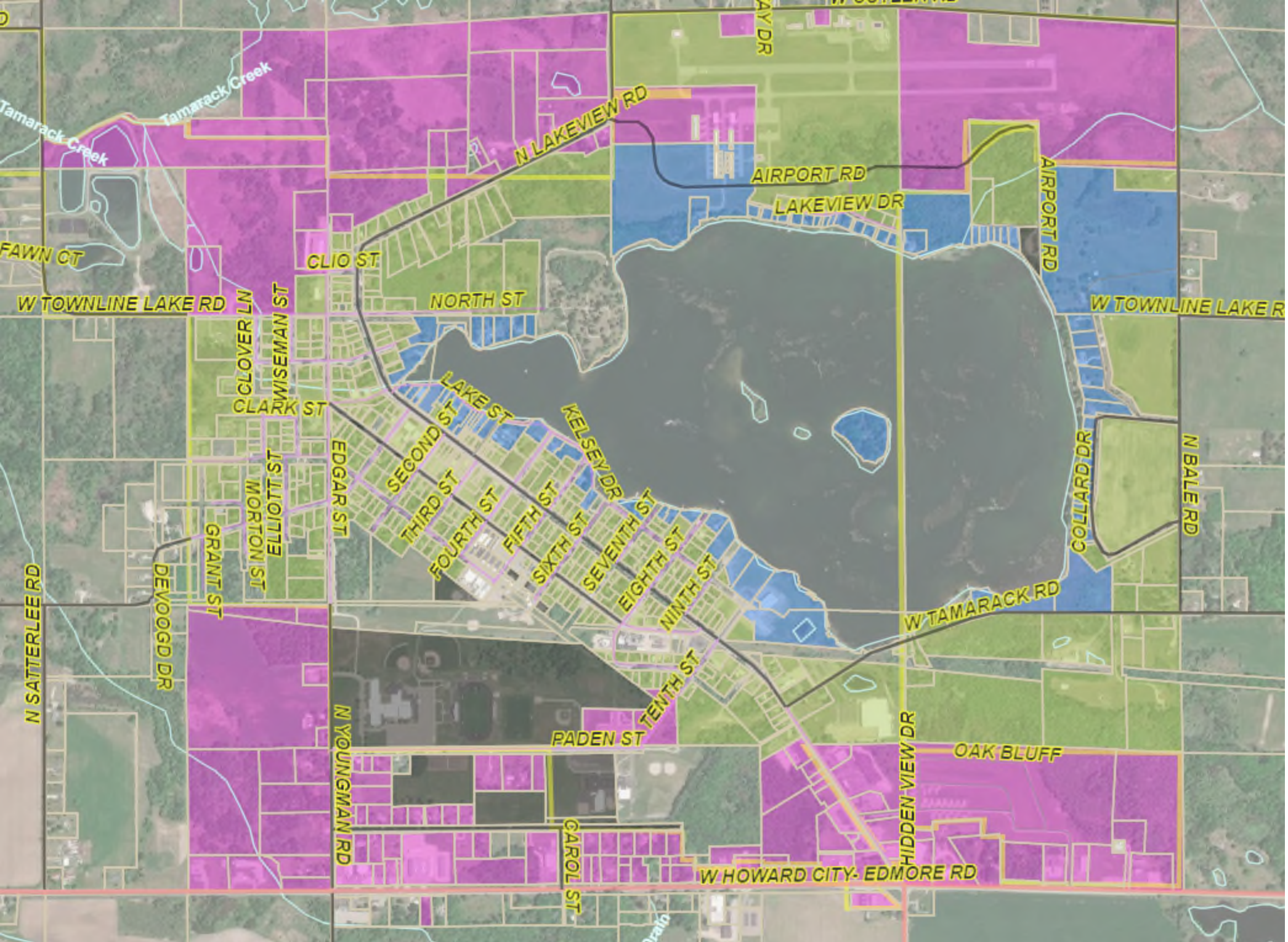

Dear Tamarack Lake Improvement Board:

I am writing today in response to the notice of public hearing documentation that I recently received regarding the hearing of practicability and review of apportionments.

I have had the pleasure of living on the "north" end of Tamarack Lake for nearly eight (8) decades. In that time, I have observed what I can only describe as a disappointing deterioration of the lake. As a person (and lake front property owner) who bears one of the larger tax burdens, I have witnessed previous weed control and lake management efforts produce little to no yield, thus my concern regarding the pending special assessment.

The failure of, and overall ineffectiveness of previous weed control efforts has left my lake frontage engulfed in weeds and made my ability to use the lake for fishing, swimming, and other recreational activities severely compromised. I have also been impacted by water levels over the last several years. My property adjoins the north outlet, and during the spring each year I have experienced land erosion and flooding which has destroyed my yard along the lakefront, eroded my ability to have a functional fishing and boat dock, and this ongoing erosion is now compromising the access driveway to my home. I have contacted the Village of Lakeview each spring regarding the water levels, and I am told each time that there is nothing that can be done. Unfortunately, the overall lack of attention and concern over the last several years has now placed me in a situation where the only way I can address the erosion issue is to install a retaining wall on nearly the balance of my lakefront property to prevent further erosion and ultimate degradation of my driveway access (if no remediation efforts are taken to address the erosion I will also incur the expense of relocating my driveway).

Consequently, I would like to go on record as opposing the special assessment without a clear directive and evidence of how forthcoming and resulting efforts of the increase will address and remediate the ongoing weed and water-level erosion issues that I have experienced.
