June 10, 2024

A meeting of the Rainbow and Middle Lakes, Lake Improvement Board was held at the Montcalm County Drain Commission, 211 W. Main Street, Stanton, Michigan on the 10th day of June 2024 at 9:00 A.M.

The meeting was called to order by Doug at 9:04 a.m.

A motion was made by Bill and seconded by Don to approve the agenda. Motion carried.

A motion was made by Don and seconded by Todd to approve the minutes from September 20, 2023, as amended. Motion carried.

Public Comment

No public present.

Treatment Update

Mark provided a treatment update to the Board. Middle lake was treated on May 15 for curly leaf pondweed and algae. There is a big milfoil bloom due to the light winter and lack of ice on the lake. There were also many residents who had requested that the chara be removed, which has allowed more room for the milfoil to grow. Rainbow Lake was treated on May 20 for curly leaf pondweed and algae. Mark noted that milfoil has started to spread and is scheduled to treat on June 24. The Board would like to use ProCellacore later in the season to see how the other chemicals work in the meantime. Don noted that a resident was removing lily pads from the lake near his property and was advised by the DNR that he could be fined \$10,000 for the removal. Mark advised that there is no permitting required to mechanically remove lily pads. They can only be treated chemically for navigation. Don asked about water quality testing and if they should be testing for PFAS. Mark said quality testing should be completed in warmer water temps. He can ask Prien and Newhoff if they would do the testing and what they would charge.

Financial Update

Todd provided a financial update to the Board, including a current balance of \$34,971.49.

Other Business

The next meeting will tentatively be held on September 9 at 9:00 am, pending Mark's availability.

There being no further business to come before the Lake Board, a motion was made by Don and seconded by Bill to adjourn the meeting at 9:37 a.m. Motion carried.


