Treatment Update

Mark provided a treatment update to the Board. He advised that a treatment was completed on 5/15 for curly leaf pondweed and algae. A second treatment was completed on 6/12 for a large algae bloom, but no curly leaf pondweed was present. Mark noted that the warm winter and hot temperatures caused the substantial algae bloom. The next treatment is scheduled for 7/31 for algae and a weed touch up, if necessary.

Fish Stocking

Joan noted that the fish are still too small to stock the lake, so they will want to hold off this season.


Financial Update

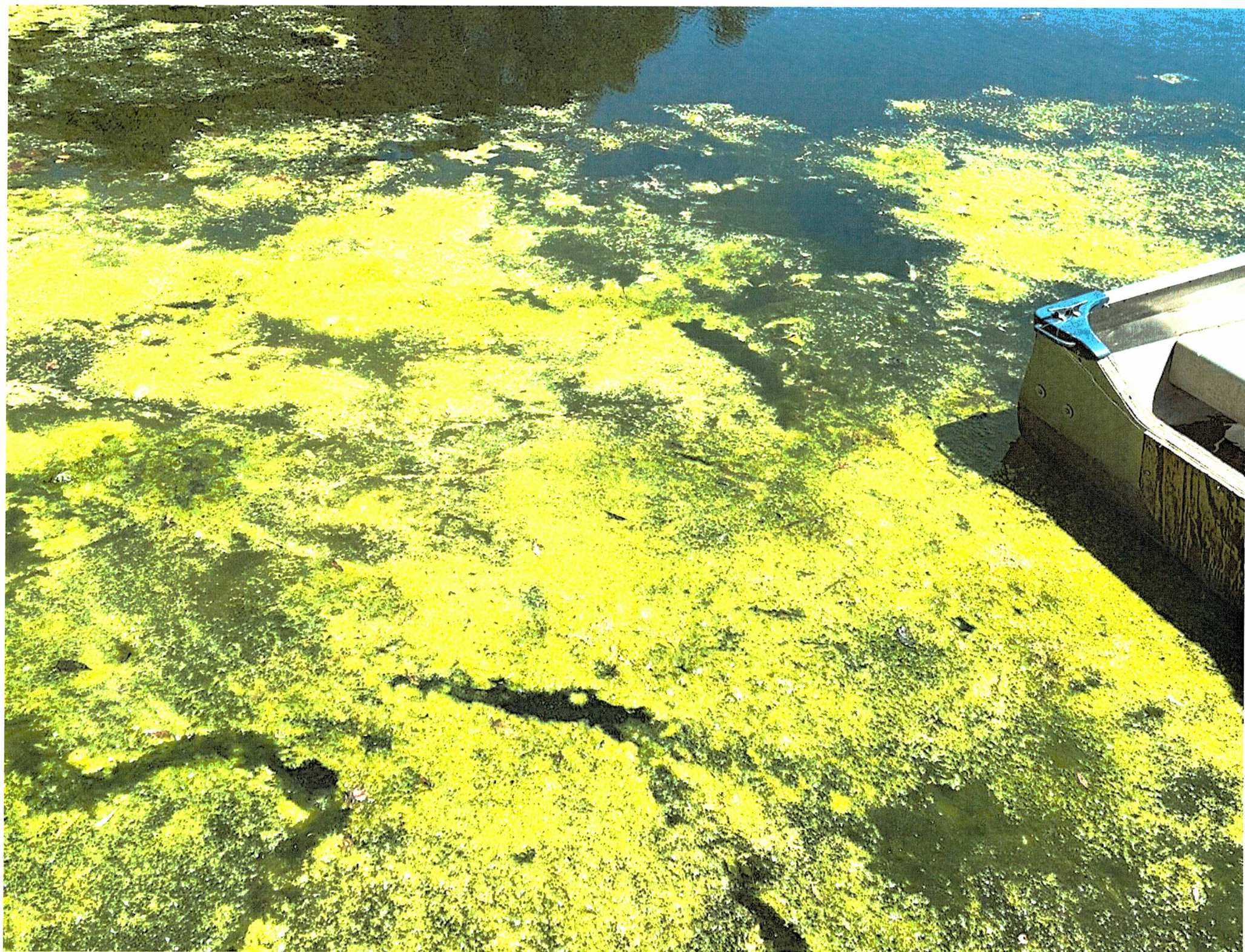

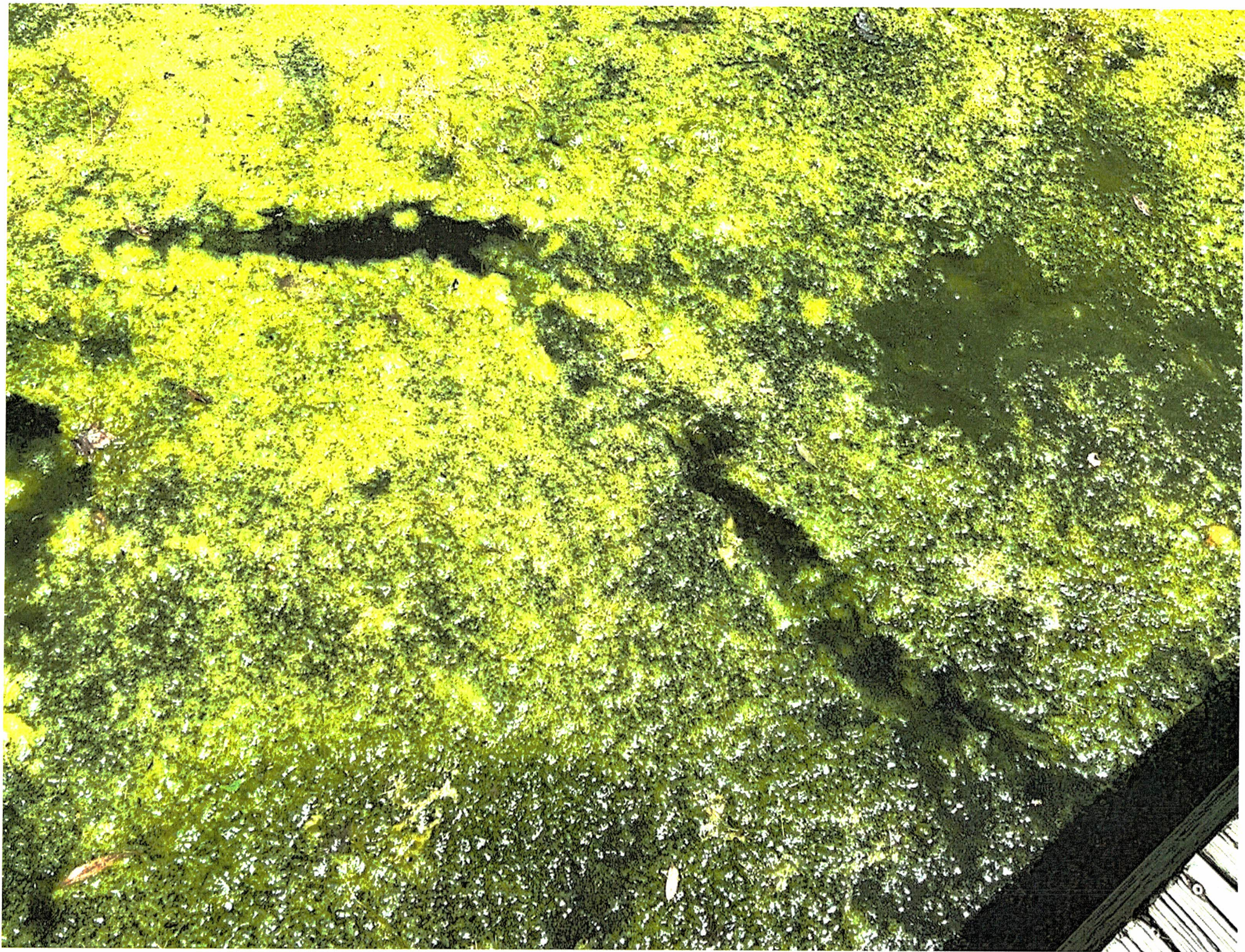
