Weed Control Program

Luke provided a treatment update to the board. He noted that there is currently \$943.69 left in the treatment budget for the season. With the remaining budget, he would only be able to treat 18 areas of lily pads. Sara asked if they could use surplus funds to treat all necessary areas. Todd said yes and he recommended it to be able to stay on top of the lily pad growth going into next season.

A motion was made by Todd and seconded by Daniel to use the remaining treatment balance and surplus funds to treat the lily pads as marked by Luke in the treatment map. Motion carried.

Financial Update

Todd provided a financial update to the board, including a current balance of \$18,593.73. He added that the board is in pretty good shape and earning about \$50 a month in interest. Sara noted that Mark Hill does not want the \$100 from the LIB for usage of his boat launch, but the board would still like to send it as they appreciate the launch and Progressive does too.

Assessment Roll Review

Todd provided an updated assessment roll to the board. He noted that there was 1 combination complete this year.

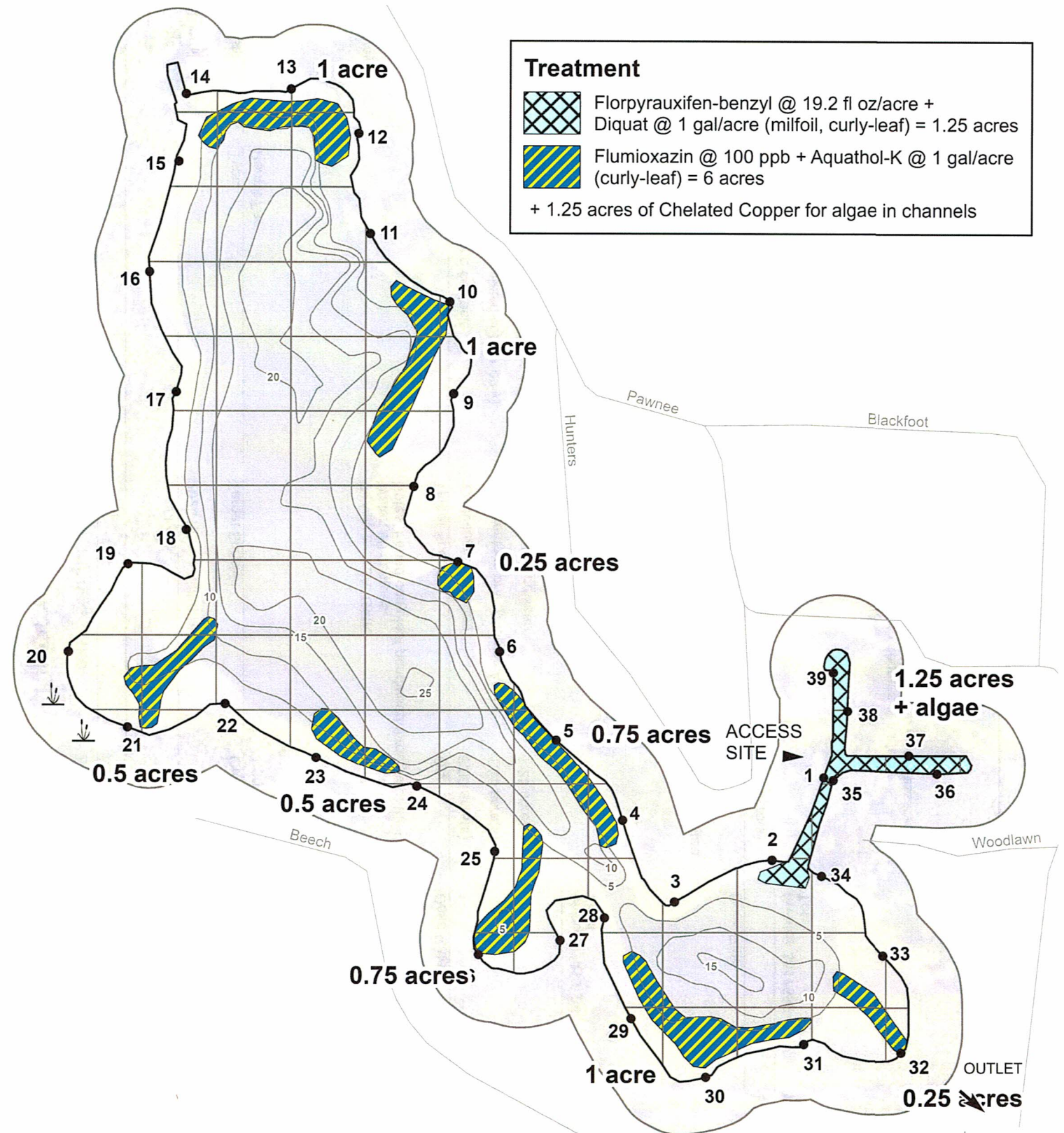

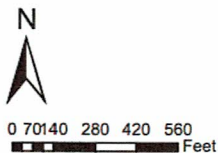
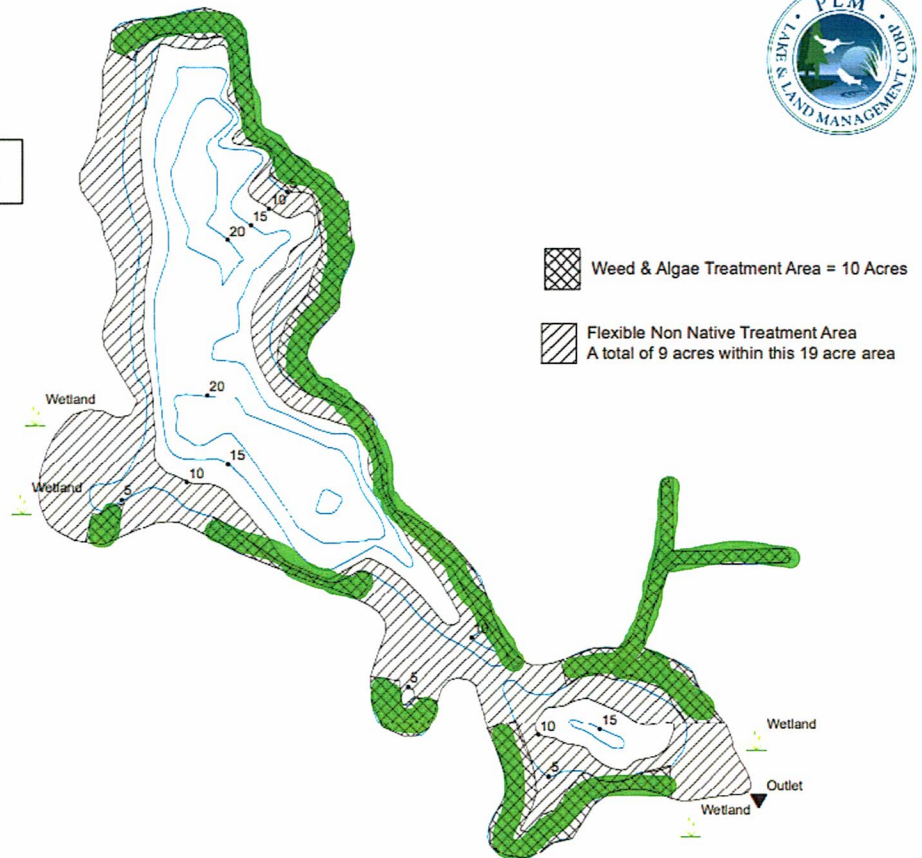
