

**LITTLE BASS LAKE

September 9, 2025

A meeting of the Little Bass Lake, Lake Improvement Board was held at the Montcalm County Drain Commission, 211 W. Main Street, Stanton, Michigan on the 9th day of September 2025 at 4:00 P.M.

The meeting was called to order by Todd at 4:08 p.m.

A motion was made by Margaret and seconded by Mary Anne to approve the agenda as presented. Motion carried.

A motion was made by Margaret and seconded by Mary Anne to approve the minutes from June 9, 2025, as presented. Motion carried.

Public Comment

No public present.

Treatment Update

Mark provided a treatment update to the board. He noted that there were three scheduled treatments and one additional treatment. Algae was heavy this season due to the heat and low water levels. There was no milfoil growth, which is great. Water quality samples came back clean. Margaret asked about treating the lily pads. Mark said they can treat them and asked the board to let him know which addresses they want to be treated. He can still get out there this season if they get the list to him quickly. Mary Anne provided a list of addresses that they knew for sure wanted treatment and will let him know if there are more.

Financial Update

Todd provided a financial update to the board, including a current balance of \$21,903.57 in the treatment budget and \$1,000.00 in the fish stocking budget. He noted that they are earning around \$55 a month in interest. Margaret stated that a couple of residents have asked if they can lower the assessment since they are holding such a high balance. Todd

noted that they have already lowered the assessment from \$7,835 to \$5,000 to burn down the balance. He is hesitant to lower it even more in case there is a large bloom.

Assessment Roll Review

Todd provided an assessment roll to the board for a total of \$5,000. He added that there were no splits or combinations and the same 84 parcels will be assessed and the residents will receive the same assessment as in 2024.

Other Business

Mary Anne asked about the low water levels and whether it would be feasible to excavate the spring that feeds into the lake. Todd said it would be very costly and not likely have a large benefit. He believes that the predicted winter will bring the water levels back up for this lake.

There being no further business to come before the Lake Board, a motion was made by Mary Anne and seconded by Margaret to adjourn the meeting at 4:36 p.m. Motion carried.
